

## Beware Of Scammers Offering Help with Getting Advanced Child Tax Credit Payments

We know a lot of eligible families are excited to learn how to get part of their Child Tax Credit in advance this year. So are scammers.

### Here are some common scams to avoid:

1. Don't fall for anyone making calls, sending emails, texts or direct messages, or posting on social media offering to help you apply for child tax credit benefits or offering ways to get advanced payment money quicker or get you more money through a larger child tax credit.
2. Also don't provide any personal information in response to advertisements, especially any individual or company asking for the following information:

- Social Security, credit union account, debit and credit card numbers or other financial information
- Home address, work address or telephone number(s)
- Any tax return-related information



The IRS will never ask for you to pay by cash, gift card, credit card, wire transfer or cryptocurrency to get help with making sure you get the necessary information to receive this payment.
